I] Prudential norms for Farm Loans –

The RBI vide letter No.DBOD.BP.BC.102/21.04.048/2003-04 dated 24-6-04 informed that the current prescription of not exceeding two half years is inadequate for income recognition, asset classification and provisioning of all direct agricultural advances. In order to align the repayment dates with harvesting of crop, it has been decided that w.e.f. 30-9-04, the following norms will be applicable to all direct agricultural advances –

- a. A loan granted for short duration crops will be treated as NPA, if the instalment of principal or interest thereon remains overdue for two crop seasons.
- b. A loan granted for long duration crops will be treated as NPA, if the instalment of principal or interest thereon remains overdue for one crop season.

For the purpose of these guidelines, long duration crops would be crops with crop season longer than one year and crops, which are not long duration crops, would be treated as short duration crops. The duration of the crop [period up to harvesting] has to be discussed and determined in the SLBC.

As per the Package of Practices published by University of Agricultural Science, the duration of different crops is furnished in the **Annexure-XX**.

I] Prudential norms for Farm Loans –

- b. A loan granted for long duration crops will be treated as NPA, if the instalment of principal or interest thereon remains overdue for one crop season.

For the purpose of these guidelines, long duration crops would be crops with crop season longer than one year and crops, which are not long duration crops, would be treated as short duration crops. The duration of the crop [period up to harvesting] has to be discussed and determined in the SLBC.

As per the Package of Practices published by University of Agricultural Science, the duration of different crops as furnished in the **Annexure-XX** was approved. Crop loans extended to Coffee, Traditional/Non-traditional

plantation/horticulture be treated as short term loans since the interval between two peak harvests does not exceed one year.

In case of KCCs, where aggregate credit limit is sanctioned to cater to the needs of different seasonal crops, the due date may be considered as 30th June of succeeding year for the cumulative disbursements made during the particular financial year.
