The meeting was convened in accordance with the directions of the **Hon'ble Union Finance Minister, Government of India**, issued during her visit to Karnataka from 14th to 17th October 2025. The purpose of this special meeting was to comprehensively review the existing KCC coverage in Vijayanagara district and chart out a structured approach for achieving **100% saturation**.

The Convenor, SLBC Karnataka presented the updated KCC position using FRUITS and SLBC data to the house. The consolidated figures are provided below for reference:

During the meeting, Chairperson highlighted the need for meticulous verification of non-KCC farmers using **Hash of Aadhaar**-based data. The importance of inter-departmental coordination involving the Agriculture, Horticulture, Animal Husbandry, and Revenue Departments as well as the District Administration was emphasized.

Deputy Commissioner and Chief Executive Officer, Vijayanagara to coordinate the KCC saturation effort in Vijayanagara district.

It was agreed that the **special KCC saturation campaign** will be conducted from **17th November 2025 to 31st December 2025**, during which weekly progress reports will be reviewed by SLBC Karnataka.

All banks were instructed to streamline documentation, accelerate the sanctioning of KCC accounts, and promote Rupay Kisan Cards for digital service delivery. Similarly, line departments were tasked with facilitating farmer identification, mobilisation, and verification as per the finalised non-KCC lists.

The meeting concluded with all stakeholders reaffirming their commitment to achieving **100% KCC saturation** in Vijayanagara district within the stipulated period, in full compliance with the guidance of the Hon'ble Union Finance Minister.
